


Where can I access Black's Law Dictionary? First published in 1891, Black's is now in a 6th edition that reflects changes in tax, finance, commerce, health care, environmental and criminal law. Terms are listed alphabetically with cross-references, and entries give basic legal definitions, word usages, citations, and pronunciation. Entries range in length from one sentence to multiple-pages with subdivisions. Appendices include a copy of the Constitution, a time chart, Supreme Court membership, and an organizational chart of the federal government. This is not only a standard reference tool for law, but an important supplement to all high school social studies courses. Also available in a 1992 abridged edition. Response sent on 13 September 2021 Your request has been handled under the Freedom of Information Act 2000 (FOIA). The UK Supreme Court partially holds the information to two of your questions but does not hold information relating to the rest of your request. I will deal with each aspect of your request in turn. Why do so called law organisations use Black's law dictionary?? Black's Law Dictionary is a standard published work of legal reference published in several editions by a well-known and reputable law publisher for over 100 years. The UK Supreme Court library holds a hard copy. Black&#8217;s Law Dictionary is not used as the sole source for legal definitions; there are many other similar sources and several of them are held in the UK Supreme Court library. I find it very deceitful to treat a living man/woman as a vessel and to deciet them into consent do you not?? Do you swear to tell the truth so help you God?? The above two questions are not requests for recorded information. I should explain that the Freedom of Information Act 2000 (FOIA) can only be used to access recorded information held by a public body. It cannot be used to obtain guidance, opinions, conjecture, or legal advice. For example, a request for recorded information would be for a copy of a policy, rather than an explanation as to why we have that policy in place. We only hold information relating to the UK Supreme Court (UKSC) and not the wider court service; the role of this court is to act as the final court of appeal in the UK for civil cases, and for criminal cases from England, Wales, and Northern Ireland. The UKSC hears cases of the greatest public or constitutional importance affecting the whole population. Why are the courts and police registered companies if they are meant to be public services?? The Supreme Court sits at the apex of the United Kingdom's legal system, hearing appeals from courts in England and Wales, Scotland, and Northern Ireland. The Court is a non-ministerial department and was established by the Constitutional Reform Act 2005 and therefore does not need to be registered as a company.
